The offenses listed below do not require a court appearance, if you have not had three (3) or more moving violations within the last twelve (12) months. You may pay the stated amount in person at the Eaton Municipal Court or you may send a money order or certified check made payable to **Eaton Municipal Court, 1199 Preble Dr., Eaton, Oh. 45320**. Please sign the back of your ticket and return it along with your payment. If you wish a receipt, or the officer did not return your license, please enclose a self-addressed, stamped envelope.

If a personal appearance is required, bring proof of insurance for the date on your traffic violation ticket. This proof may be a form or letter from your agent, or the form provided to you by the officer or the Court, or the current face sheet of your policy, indicating your name and the vehicle you were driving. If you were driving someone else's car, and your name is not on their policy, you must bring a form or letter signed by their agent, showing that you were covered driving that car. You must be prepared to pay your fine and costs upon appearance.

Failure to appear or pay the fine will result in a two or three week continuance, depending on whether you have a mandatory appearance or not. **FAILURE TO APPEAR OR PAY THE FINE WILL SUBJECT YOU TO ARREST AND/OR CANCELLATION OF YOUR LICENSE.**
